Guidelines

- Scholarship Policy

Any scholarship awarded by the *AGBU Musical Armenia Program* is intended to serve only as a partial waiver of the \$1,500 fee required of each participant. No part of this award will be transferred directly to the student at any time, but instead will be automatically applied towards the payment of the applicant's participation fee by the *AGBU Musical Armenia Program* administration.

- Eligibility for Scholarship

Your application for a scholarship will be evaluated based on the following considerations: academic and artistic merit, financial need (and any special circumstances affecting this need), the degree of your interest in our program, and your desire to participate.

- Application Deadlines

The deadline for submitting your *Application for Financial Assistance* form along with copies of your most recent parental and personal federal and state tax returns to the *AGBU Musical Armenia Program* office is **Monday, June 5, 2017.**

- Award Notification
